### MUSIC LESSON PAYMENT INFORMATION:

Private lessons are \$560 per student, per semester due **January 15, 2018**.

Group Lessons are \$460 per student, per semester due **January 15, 2018**.

Until all balances of tuition and fees, including music fees, are paid in full: 1) grades will not be issued; 2) student transcripts will not be released to other high schools, colleges, and/or testing institutions; 3) the student will not be allowed to re-enroll for the following year. If collection procedures are necessary, the person(s) responsible for payment of the account will be liable for all fees, costs, and expenses incurred including, but not limited to, reasonable attorneys fees, court costs, and interest

### WITHDRAWAL PROCEDURES AND LIABILITY:

THE PERSON(S) RESPONSIBLE FOR PAYMENT OF THE ACCOUNT IS/ARE OBLIGATED TO PAY in advance for the entire semester of 14 lessons. **There are no refunds;** however, if a student withdraws prior to taking the fifth lesson in a semester, the balance of the music fee can be applied to a subsequent Academy tuition payment.
